Religious Education Program Family Handbook 2018-2019

The purpose of the handbook is to set forth the guidelines for those that participate in the Saint Philip Neri Religious Education Program. By enrolling your child(ren) in PREP, you acknowledge your acceptance and cooperation with the policies of the Handbook. Parents are therefore encouraged to discuss these provisions with their children to ensure that all parties understand the requirements and obligations of their participation in the Parish Religious Education Program.

Dear Families:

Welcome back! The people of Saint Philip Neri Parish guided by the beliefs and teachings of the Catholic Church, and trusting in the inspiration of the Holy Spirit, commit ourselves to the service of the Kingdom of God. Through Baptism we become children of God; in Confirmation we receive the Holy Spirit who continuously guides us; through the Sacrament of Reconciliation our sins are forgiven; and, in Holy Communion we receive Jesus, the Light of the World, who transforms each of us into a new and holier person. In union with our Holy Father, the Pope, we wish to build up the Kingdom of God.

TO TEACH AS JESUS DID, we wish to draw on a deeper knowledge of his presence in our lives by:

RENEWING OUR LIVES through prayer, retreat, reception of the Sacraments of Penance and the Holy Eucharist. We commit ourselves to be continually educated; opening ourselves to the teachings of the Church, and to passing on what we have learned.

LIVING PRAYERFULLY. We can, through his presence in us, draw the children and the families entrusted to us to our God.

WE DESIRE TO CREATE AND NOURISH CHRISTIAN COMMUNITY by the compassion and respect with which we treat each other.

WE DESIRE TO PROCLAIM THE GOOD NEWS BY SHARING THE INFORMATION of who God is and how He works in our lives.

WE DESIRE TO PROMOTE A RELATIONSHIP between those who are in the REP program and the senior citizens of our parish.

WE ENCOURAGE FAMILIES TO PARTICIPATE by becoming altar servers or by bringing the bread and wine up in the Presentation of the Gifts, during the Liturgy.

WE PRAY that our parish may become for all a center of spiritual development, a place of prayerful peace and meaningful community worship.

MISSION OF RELIGIOUS EDUCATION

St. Philip Neri Parish is committed to the religious education of its children as taught by Jesus Christ. Our goal is to assist you as your child's first teacher, to nourish the faith which you instilled through instruction in Church doctrine, and to prepare children for the reception of the sacraments in accordance with our Church teachings:

- "Parents have the first responsibility for the education of their children" (CCC #2223).
- The catechesis given by parents with the family "precedes, accompanies, and enriches all other forms of catechesis" (NDC p 234-5, CT #68).
- This "education of the faith is brought about by catechesis which "includes the teaching of Christian doctrine in an ordered and systematic way, with a view to initiating the hearers into the fullness of Christian life" (CCC #5 and *Catechesi tradendae* #8).

Religious Education is a life-long journey. Since we catechists have only a brief period of time with your children, we will need your continued support and affirmation of this life-giving message. As parents, your modeling of the faith and full participation at Mass is the best and most effective method to hand on the faith. As a community of believers we look forward to assisting you and your children in this great act of salvation, with the help of the Holy Spirit, to know, love, and serve God.

KEEPING GOD'S CHILDREN SAFE/SAFE TOUCH LESSONS

St. Philip Neri PREP complies with all Archdiocesan Policies and Procedures to ensure a Safe Environment for our children. The Archdiocese is required to teach one personal safety lesson per year, entitled "Keeping God's Children Safe." These lessons will be taught on Monday, February 11 and Tuesday February 12. If class must be canceled because of inclement weather, the lessons will be taught on the next available class date. Parents/guardians may opt out their children from the lesson by signing an Opt Out form available in the Religious Education Office. An alternate lesson will be provided for children who "opt out."

EVALUATION

Although faith development cannot be measured numerically, effort must be made to note progress, participation, cooperation and conduct that we experience with each child. Each Catechist will communicate to you his or her method of evaluation.

PROGRESS REPORTS

You will also receive a report card as to how your child is doing during the year. Please call us if you have any concerns or questions. We appreciate your keeping in touch with us.

BAD WEATHER DAYS

Children who arrive early are permitted time to play outside. If the weather is not conducive to outdoor play, the children will go to an assigned spot inside. The catechist or aide will bring them to class when it is time to begin.

REFRESHMENTS

Water and a snack period will be provided for the children ten minutes during class. Pretzels will be offered for a fee around \$15 (subject to change) per child for the year. **If the pretzels are not purchased, please provide a snack for your child.**

DISMISSAL

Please park your car in a designated parking spot and walk in, using the Main Entrance, to pick your child up. Children will be dismissed from the gym. Please go to the grade level catechist and sign your child out.

If there is someone who may NOT pick up your child, please notify the administrator.

BUSSING

Bussing is available for children who attend Whitmarsh Elementary, Ridge Park, or Colonial Elementary Schools for a fee, listed below. Unfortunately, we are not able to bus from other locations. Parents whose children are taking the bus must write letters of permission to their child's school. All PREP behavior policies will apply on the PREP bus.

POLICIES & PROCEDURES

ATTENDANCE

The faith formation received in the programs is ongoing in that each session builds upon the previous session. Therefore, it is imperative that children attend their program sessions regularly.

If your child is unable to attend a session for any reason, a parent **MUST** complete the following procedures:

1. Call 484-804-1875 before 3 PM or 610-828-3082 ext. 2 (**Do not leave any message on the school's attendance line**) to report the absence on the day of their Program. Please be sure to leave your child's name and grade level and reason for absence.
2. After the third absence, the program director will contact the parents by phone or email to notify parents that the child may be required to repeat the grade level and that dismissal from the program could result should absences continue. Frequent absences which are not remedied may result in the student not being permitted to continue in classroom catechesis or having to repeat the year. An assessment may be required for promotion.
3. Parents should be in regular contact with their child's catechist in an effort to obtain assignments and keep their child's formation up-to-date when possible.
4. Children who are routinely late or dismissed early miss important class time. Accumulated minutes may be added up and treated as an absence.

HOME WORK AND MISSED ASSIGNMENTS

Each Catechist will communicate his or her own homework and missed assignment make up policy. If homework is assigned, it is expected to be completed on time. If a child regularly misses homework or fails to complete missed assignments, parents will be notified by the catechist. If that fails to resolve the problem, the DRE may be called upon to intervene.

WORKBOOKS

Every participant is assigned a workbook at the beginning of the year and is required to bring the workbook to **EVERY** program session. Please be aware that some catechists may keep the workbook in their classrooms.

NON-CUSTODIAL PARENTS

It is the responsibility of both parents to provide the Parish with the latest, most up to date Custodial Order or Custody Agreement. Saint Philip Neri will request these documents in the beginning of the year. If either the Custody Order or Custody Agreement changes during the course of the year, it remains the responsibility of both parents to provide that document to the Parish immediately.

Our program abides by the provisions of the Buckley Amendment with respect to the rights of non-custodial parents. In the absence of a court order to the contrary, our program will provide the non-custodial parent with access to the records and other program related information regarding the child. If there is a court order specifying that there is to be no information given, it is the responsibility of the custodial parent to provide the program director with an official and latest copy of the court order.

If a court order prohibits our releasing a child into the custody of a non-custodial parent, it is the responsibility of the custodial parent to provide the program director with an official copy of the court order or custody section of the divorce decree.

DISCIPLINE

The Parish Religious Education Program offered is designed to assist parents with the faith formation of their children, as well as foster values and behavior that are in accord with Catholic Church teaching. The program has **NO TOLERANCE** for behaviors that are contrary to Catholic faith and morals, including but not limited to ongoing acts of obstinacy, improper language, fighting, physical, emotional or psychological intimidation, vandalism, demeaning behavior such as name-calling, obscene language or gestures. Such behaviors violate the central teaching of our faith and will not be tolerated in any form.

Conduct by children or parents/guardians, or anyone acting on their behalf, incompatible with the educational and religious mission of the Parish is grounds for disciplinary action.

In the event a participant engages in any of the above listed behaviors or any other inappropriate conduct, and has failed to respond to a catechist's attempt to stop or correct the behavior, the following action may be taken and at the discretion of the Pastor or Director of Religious Education:

1. **First Incident:** The student will be removed from the session and the parent or guardian will be immediately notified by phone by the program director. The program director will schedule a conference with the parents/guardians, student, and catechist to discuss the matter.
2. **Second Incident:** The student will be removed from the session and be suspended from the program for a period of one session. The parents/guardians will be immediately notified by the program director and required to pick up their child. Prior to returning to the program the program director will schedule a conference with the parents, student, and catechist to further discuss the matter.

3. **Third Incident:** The student will be removed from the session and dismissed from the program. The parents or guardians will be immediately notified by the program director and required to pick up their child. Following a conference with the program director, parents, student, and catechist, the parents will be provided with the option of having their child repeat his or her current grade level the following school year or opting to complete the current year's material by homeschooling their child. In either case, no refund of tuition or material fees will be made.

However, Saint Philip Neri reserves the right to supersede the forgoing course of action depending on the particular circumstances of any given situation.

Our Discipline Policy is based on respect and reverence for all life, during the time at PREP including riding on the bus:

- Children must respect the property of others, and follow the instruction of the Catechists and Yard Monitors.
- The parish grounds and building are the property of everyone and must be used with respect.
- Supervised play will be provided before class, children are to be inside the area blocked off by the orange cones.
- When the bell rings, the children are to stand in line and wait for the Catechist or aide to bring them to the classroom
- WALKING QUIETLY is required in the hallways.
- Lavatories may be used properly.

In addition, in the case of threats of violence or harassment in any form, including but not limited to oral, written, or electronic, by a child against any member of the CCD community, the child, if suspended but not dismissed, may be required to have psychological or psychiatric clearance before returning to the program.

- **Contraband**

Bringing contraband to CCD is strictly prohibited and will be confiscated and returned to parents only. It is unlawful for minors to be in possession of weapons, drugs, alcohol, or tobacco. Depending on the contraband confiscated, the proper legal authorities could be notified. Items considered contraband include, but are not limited to: weapons, drugs, alcohol, tobacco, toys, electronic entertainment, etc.

We realize that devices such as cell phones have become a necessary tool in keeping communications open with children, especially for working parents. However, it is the policy of this program that such devices may not be used during catechetical sessions. If a student uses a cell phone during the program, the device will be sent to the school office and must be picked up by a parent/guardian.

- **Search and Seizure**

It is the policy of SPN PREP to respect the privacy of participants. Unnecessary intrusions into persons and possessions are to be avoided. However, in the event that a student is suspected of having weapons or drugs in her/his possession, the administrator will be notified immediately. The administrator will conduct a search with an adult staff member as witness. Refusal on the part of the participant to cooperate will result in the parents/guardians being contacted and asked to assist in the search. Parental refusal will result in the participant's immediate dismissal from the program.

FIRE DRILLS AND SAFETY PRECAUTIONS

We will conduct a fire drill to insure the safety of all students, teachers and staff. Students are asked to follow the directions given to them by their catechist. They should leave the building in a quiet and orderly manner.

The state of Pennsylvania and the Federal Government have mandated that every effort be made to protect children, teachers and staff from the possibility of transmitting an infectious disease. We will comply with these regulations. Disposable gloves are available in case of an emergency.

- **Allergies and Medical Emergency Plans**

If your child has a severe allergy, please notify the administrator. If you have a Medical Plan from your doctor, please provide a copy to the administrator. Please be aware that we do not have a nurse on staff. In the event of an allergic reaction, parents will be notified and we will call 911. Parents are welcome to remain on site to administer medication if necessary. Please speak to the administrator.

- **Shelter in Place and Evacuations**

We follow the Shelter In Place protocol established by SPN School. Parents will be notified as soon as possible in an emergency situation. Should our program be instructed to *shelter in place*, we would notify each classroom via the PA system. Children will be escorted to the Cafeteria/Social Hall. Roll be taken. Staff will be instructed to secure doors and windows if possible. Once the “All Clear” sign is given, we will dismiss children only to their parents.

Should we need to evacuate the building, staff will direct children to use the nearest exit. We will all meet in the Church. Parents who are already present may elect to wait with their children, but no one will be permitted to re-enter the building or be dismissed until emergency personnel give the direction. Please be prepared to show identification when picking up your child after an evacuation.

Please obey all law enforcement and emergency personnel if there is an emergency. Do not block driveways and be mindful of emergency vehicles in the parking lot. Please be aware that this plan does not cover all situations. The administrator or her designee may need to make decisions. We will make a reasonable effort to keep parents informed should the plan need to change.

ACCIDENT OR MISHAP

No child may touch another child in the event of an injury. He or she may go to the Yard Monitor or Catechist to inform them of what has happened. Remind the children about this. You will be notified if anything serious occurs.

EMERGENCY CLOSING

We follow the decision of the Colonial School District and St. Philip Neri School with regards to the decision to cancel PREP due to inclement weather. When either school dismisses early, or afternoon and evening activities are cancelled, there will be NO PREP that afternoon. A message will be placed on the PREP phone, and if possible, parents will be notified via email. KYW Community Cancellation List (1060) will also be notified. Parents and child may be assigned work to do at home together.

Please Note: The decision to cancel in the event of an evening snowstorm, even if CSD does not cancel, may be necessary if our lot & sidewalks cannot be cleared.

As soon as a decision is made, you will be notified. These procedures would also apply to unplanned possibilities like no heat or electricity. In any event, your child should always know what to do in case of an emergency closing should it happen on a Monday or Tuesday **during school**.

REGISTRATION FOR PARISH RELIGIOUS EDUCATION PROGRAM

- Families must be registered members of St. Philip Neri Parish in order for children to participate in the religious education program. Exceptions may be made on a case-by-case with the approval of the pastor.
- All forms must be filled out completely and a copy of the Baptismal Record must be provided before enrollment is processed. No child will be admitted to the Sacraments without a valid Baptismal Record on file.
- If a child is transferring from another program, a copy of the permanent record must be provided.
- Because Religious Education builds upon the previous year, it is essential that participants remain enrolled in the program consistently. Children who miss a year or more of religious education will be required to complete the missed the year. The DRE will work with parents/guardians to assist them in meeting the requirements.

Payment/ Fees

- \$225 for one child, or \$300 for two or more children.
- Bussing is available for children who attend Whitemarsh Elementary, Ridge Park, or Colonial Elementary Schools. Bussing fees are \$60 per family. Unfortunately, we are not able to bus from other locations.

No child will be refused due to the inability of the family to pay. Please discuss with pastor as necessary.

Children with Disabilities

St. Philip Neri PREP accepts children of all abilities. We will work closely with parents to build inclusive classroom experiences for all children, to the extent that each individual child can participate. If your child has any exceptionalities, requires modification of materials, or other needs, please speak with the administrator. Please provide a copy of your child’s IEP if applicable.

Renewal

Renewal takes place in the spring for the following academic year. Parents are asked to provide updated information with regards to any special educational, custody agreements and medical/allergy information when enrolling.

HOME SCHOOLING POLICY

Requests to homeschool will be considered on a case-by-case basis and must be approved by the Pastor or his delegate, the DRE. St. Philip Neri follows the Guidelines for Home Based Catechesis of the Archdiocese of Philadelphia.
